HOUSE BILL NO. 767

BY REPRESENTATIVE BOWLER

AN ACT

To amend and reenact R.S. 22:15(B)(1)(c), (e), (g), (o), (p), (q), and (r) and (2)(a)(iv), (vi), (vii), and (xvi) and (b)(vii) and (x), and (c)(vii), (x), and (xi), to enact R.S. 22:15(B)(1)(t) and (u) and (2)(a)(xvii) and (xviii), (b)(xi) and (xii), and (c)(xii) and (xiii), and to repeal R.S. 22:15(B)(1)(b) and (2)(a)(iii), relative to the Louisiana Property and Casualty Insurance Commission; to provide for membership; to provide for designees; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 22:15(B)(1)(c), (e), (g), (o), (p), (q), and (r) and (2)(a)(iv), (vi), (vii), and (xvi) and (b)(vii), and (x), and (c)(vii), (x), and (xi) are hereby amended and reenacted and R.S. 22:15(B)(1)(t) and (u) and (2)(a)(xvii) and (xviii)(b)(xi) and (xii), and (c)(xii) and (xiii) are hereby enacted to read as follows:

§15. Louisiana Property and Casualty Insurance Commission

* * *

B.(1) The commission shall consist of the following members:

* * *

(c) The assistant secretary of the Louisiana Department of Public Safety and Corrections, office of motor vehicles, or his designee.

* * *

(e) ~~The president of the Louisiana Association of Chiefs of Police or his designee.~~ A representative of the Louisiana Association of Fire and Casualty Companies, selected by its governing body, or his designee.

* * *

(g) ~~The president of the Louisiana Sheriff's Association or his designee.~~ A representative of the National Association of Independent Insurers, selected by its governing body, or his designee.

* * *

(o) The executive director of the Louisiana Highway Safety Commission or his designee.

(p) A representative of the Property Insurance Association of Louisiana appointed by its governing committee or his designee.

(q) A representative of the Louisiana Workers' Compensation Corporation appointed by its board of directors or his designee.

(r) A representative of the Department of Labor, office of workers' compensation or his designee, appointed by the secretary of labor.

* * *

(t) A representative of the Alliance of American Insurers, selected by its governing body, or his designee.

(u) A representative of law enforcement or his designee, selected jointly by the superintendent of state police, the secretary of the Department of Public Safety and Corrections, the president of the Louisiana Association of Chiefs of Police, and the president of the Louisiana Sheriff's Association.

(2) The commission shall consist of ad hoc committees to study property and casualty insurance, including but not limited to the areas of automobile insurance, homeowners insurance, and workers' compensation insurance. The commissioner of insurance shall appoint a chairperson and a vice chairperson for the commission and a chairperson and vice chairperson for each ad hoc committee.

(a) The automobile insurance ad hoc committee shall consist of the following members:

(iv) The assistant secretary of the Louisiana Department of Public Safety and Corrections, office of motor vehicles, or his designee.

(vi) ~~The president of the Louisiana Association of Chiefs of Police or his designee.~~ The representative of the National Association of Independent Insurers or his designee.

(vii) ~~The president of the Louisiana Sheriff's Association or his designee.~~ The representative of the Louisiana Association of Fire and Casualty Companies or his designee.

* * *

(xvi) ~~A member~~ The chairperson of the Louisiana Insurance Rating Commission or his designee.

(xvii) A representative of the Alliance of American Insurers, selected by its governing body, or his designee.

(xviii) The representative of law enforcement or his designee.

(b) The homeowners ad hoc committee shall consist of the following members:

(vii) ~~A member~~ The chairperson of the Louisiana Insurance Rating Commission or his designee.

* * *

(x) A representative of the Property Insurance Association of Louisiana appointed by its governing committee or its designee.

(xi) The representative of the Louisiana Association of Fire and Casualty Companies or his designee.

(xii) The representative of the National Association of Independent Insurers or his designee.

(c) The workers' compensation insurance ad hoc committee shall consist of the following members:

(vii) ~~A member~~ The chairperson of the Louisiana Insurance Rating Commission or his designee.

(x) A representative of the Louisiana Workers' Compensation Corporation appointed by its board of directors or his designee.

(xi) A representative of the Department of Labor, office of workers' compensation or his designee, appointed by the secretary of labor.

(xii) The representative of the National Association of Independent Insurers or his designee.

(xiii) A representative of the Alliance of American Insurers, selected by its governing body, or his designee.

Section 2. R.S. 22:15(B)(1)(b) and (2)(a)(iii) are hereby repealed in their entirety.
