27 fifteenth of each year during which the person holds an office or position included  
28 in Subsection A of this Section and, except as provided in Subsection B(2) of this  
29 Section by May fifteenth of the year following the termination of the holding of such  
30 office or position. The financial statement shall include all the required information  
31 in Subsection C of this Section for the preceding calendar year.

32 (2) In the year in which the holding of the office or position is terminated, the  
33 financial statement required by this Section may be filed within sixty days following  
34 the termination of the holding of such office or position and the financial statement  
35 shall include all the required information in Subsection C of this Section for the  
36 period in which the person held the office or position which is true and correct to the  
37 best knowledge, information and belief of the person.

43 §1124.2. Financial disclosure; certain elected officials; members of certain boards  
44 and commissions; ethics administrator

1 A. Each of the following, except a person who is required to file a financial  
2 statement pursuant to R.S. 42:1124, shall ~~annually~~ file a financial statement as  
3 provided in this Section:

5 B.(1) The financial statement required by this Section shall be filed by May  
6 fifteenth of each year during which the person holds an office or position included  
7 in Subsection A of this Section and except as provided in Subsection B(2) of this  
8 Section by May fifteenth of the year following the termination of the holding of such  
9 office or position the financial statement shall include all the required information  
10 in Subsection C of this Section for the preceding calendar year.

11 (2) In the year in which the holding of the office or position is terminated, the  
12 financial statement required by this Section may be filed within sixty days following  
13 the termination of the holding of such office or position and the financial statement  
14 shall include all the required information in Subsection C of this Section for the  
15 period in which the person held the office or position which is true and correct to the  
16 best knowledge, information and belief of the person.

24 A. Each of the following, except a person who is required to file a financial  
25 statement pursuant to R.S. 42:1124 or 1124.2, shall ~~annually~~ file a financial  
26 statement as provided in this Section:

28 B. (1) The financial statement required by this Section shall be filed by May  
29 fifteenth of each year during which the person holds an office included in Subsection  
30 A of this Section and, except as provided in Subsection B(2) of this Section by May  
31 fifteenth of the year following the termination of the holding of such office the  
32 financial statement shall include all the required information in Subsection C of this  
33 Section for the proceeding calendar year.

34 (2) In the year in which the holding of the office or position is terminated, the  
35 financial statement required by this Section may be filed within sixty days following  
36 the termination of the holding of such office or position and the financial statement  
37 shall include all the required information in Subsection C of this Section for the

44 §1124.3. Financial disclosure; certain elected officials, voting districts of  
45 under five thousand

46 A. Each person holding a public office who represents a voting district  
47 having a population of fewer than five thousand and each member of the governing  
48 authority or management board of a charter school created pursuant to Chapter 42  
49 of Title 17 of the Louisiana Revised Statutes of 1950, except any person who is  
50 required to file a financial statement by R.S. 42:1124, 1124.2, or 1124.2.1 shall  
51 ~~annually~~ file a financial statement as provided in this Section.

52 B.(1) The financial statement required by this Section shall be filed by May  
53 fifteenth of each year during which the person holds an office included in Subsection  
54 A of this Section and, except as provided in Subsection B(2) of this Section by May  
55 fifteenth of the year following the termination of the holding of such office the  
56 financial statement shall include all the required information in Subsection C of this  
57 Section fo the preceding calendar year.

58 (2) In the year in which the holding of the office or position is terminated, the  
59 financial statement required by this Section may be filed within sixty days following

1 the termination of the holding of such office or position and the financial statement  
2 shall include all the required information in Subsection C of this Section for the  
3 period in which the person held the office or position which is true and correct to the  
4 best knowledge, information and belief of the person.

12 a financial disclosure statement who terminates his public service in 2012 shall file  
13 a financial statement including all the information required by law covering the time  
14 served in 2012 on or before March 1, 2013."
